### Educational aims of the course

- · To enable students to acquire a sound knowledge and understanding of theories and the nature of communication and particularly linguistic communication.
- · To provide a multidisciplinary, critical understanding of language and communication by examining a range of theoretical perspectives and engaging in relevant practical investigations and analysis.
- · To enable students to acquire an informed sense of the similarities and differences between modes and systems of communication, including media and business communication, thus fostering cross-cultural and international perspectives.
- To provide learners with a sound understanding and competence in English with opportunities for specialisation in subject areas relating to communication and language usage.
- To provide all students with the opportunities to develop their linguistic skills in accordance with their needs and with their overall programme objectives.

For English as the target language (TL), the programme seeks to engage students in:

- · learning all four basic language skills (reading, writing, listening and speaking);
- understanding language structures (grammar);
- · acquiring vocabulary and idiom;
- · developing English language skills to enable them to fully benefit from their subject study
- · an appreciation of Anglophone (or other foreign) culture and linguistic conventions.
- · To provide students with the opportunity to develop key skills
- · To provide students with the opportunity to develop business communication skills
- To provide students with the skills and knowledge required to maximise careers and postgraduate study opportunities in the context of changing labour markets.
- · To provide a framework allowing students to follow a flexible and coherent programme of study.
