#### Educational aims of the course

The course is designed to provide student teachers with the opportunity to study the theory and practice of education from the perspective of learners, teachers, administrators, policymakers and other key stakeholders in the system of formal education. The teaching experience is within the post-compulsory education sector and together with academic study equips the student teacher with the knowledge, understanding and skills that they need to begin to develop as a professional educator. The programme also provides a strong theoretical and research-based perspective to extend their knowledge and understanding and to allow them to reflect critically upon their own personal and professional values. Main principles that underpin this modular programme:

- To promote an excellent learning experience for all students including educational and personal success and independence in an inclusive, accessible, relevant, supportive environment
- To develop standards of good professional practice, skills and attitudes required by the postcompulsory education sector in managing the teaching and learning process, developing the curriculum and supporting the learner
- To provide a practice-based programme that creates effective opportunities for student teachers to reflect on their professional practice and enhance their teaching competence
- To apply learning theories to practice when planning, implementing and evaluating teaching and learning programmes in the post-compulsory education sector
- To generate personal and professional self-confidence from which to create a sound base for further professional and career development
- To enable the development of professional practice to a recognised national standard
- To encourage the professional sharing of subject specific experiences and knowledge relating to teaching and learning between student teachers and tutors
