Educational aims of the course

MA Fashion Marketing with Professional Experience is aimed at graduates and professionals who wish to develop a broad range of knowledge and skills for leadership careers in marketing and management within the global fashion industry. The course provides a learning environment in which both business graduates can develop creative and strategic skills and creative graduates with limited or no marketing experiences can develop a broad understanding of business and marketing practices in the fashion sector. It focuses on marketing communications and agency practices to provide graduates with a clear understanding of fashion marketing from the perspective of business growth and the 'development of positive and critical attitudes towards leadership, change and enterprise, so as to reflect the dynamism and vibrancy of the business and management environment' (2.1 QAA 2015).

The MA Fashion Marketing with Professional Experience Programme aims to:

- Provide a breadth of knowledge in fashion marketing communications, such as, consumer insight, social media marketing, fashion branding online customer experience management and digital advertising.
- Articulate a critical understanding of contemporary issues in fashion marketing from a sustainable ethical, and global perspective.
- Encourage on-going critical, evaluative and strategic thinking, which would help students to identify
 and critique fashion marketing and related practice (applications and techniques) that are
 compatible with the prevailing marketing requirements of industry and commerce.
- Preparation for a career in fashion marketing and associate business areas by developing skills at a professional and equivalent level.
- Equip graduates with necessary transferable skills for lifelong learning and flexibility in the current global marketing environment.
- Develop the ability to undertake rigorous, independent research in fashion marketing.
