The MSc International HRM Programme:

- Enables students to improve their spoken and written communication and to develop critical evaluation, persuasive argument and reflective learning skills.
- Provides opportunities for students to evaluate the strategic contribution of people professionals in organisations from a global perspective.
- Enables students to undertake an extended critical investigation of an international human resource management topic.
- Enables students to meet the core knowledge and core behaviour standards of the CIPD profession map at Chartered level. On successful completion providing students are in active CIPD membership students will automatically gain Associate membership of the CIPD. They will also gain the eligibility to potentially upgrade their membership to Chartered depending on their experience.
