- To provide students with a comprehensive understanding of the professional world of the translator and thereby to prepare them for entry into that employment sector and related areas of employment
- To provide opportunities for students to develop an appropriate expertise in specific areas, such as the application of information technology to translation (use of CAT tools and machine translation), and to experience specialised areas of translation, such as subtitling
- To give students an opportunity to undertake an independent and in-depth investigation in a subject of their own choice
