Educational aims of the course

To develop graduates equipped with the necessary skills and qualities to take roles within the Civil Engineering industry as professional engineers, and to provide an educational foundation upon which graduate engineers can build with further learning and experience in order to achieve higher professional status and responsibility.

Investigate cutting edge practices in civil engineering including fieldwork, laboratory skills, and materials selection, project planning management and implementation and to develop an awareness of quality issues.
